- SPECIAL RULES - READ CAREFULLY -

DISCLAIMER: The rules and/or regulations set forth herein are designed to provide for the orderly conduct of racing events and to establish minimum acceptable requirements for such events. These rules shall govern the condition of all events, and by participating in these events, all participants are deemed to have complied with these rules.

This race program will be run under CMS and Super DIRTcar Series rules, and in signing an Official Entry Application (OEA) or taking part in any of the events described in this OEA, all competitors acknowledge that they have received, read and understand all the rules and regulations associated with the event, and hereby agree to abide by all official CMS and Super DIRTcar Series decisions and regulations.

- 1. Minors 17 years of age and younger must submit a Parental Consent, Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement/Minor's Assumption of Risk and Release and Waiver of Liability signed by BOTH of their parents (or legal guardians). No exceptions.
2. Promoters reserve the right to refuse any application at any time and to close entry once they deem the number of entrants to be sufficient.
3. All cars will be subject to Super DIRTcar Series control from the time they enter the garage and/or pit area until they are officially released after the race.
4. One work area vehicle (ATV/UTV/Mule or similar), per entry, may be presented for credential - NO RIDERS - work area vehicles must remain in pit area and may not be used on unrestricted areas of CMS.
5. Personal vehicles will be allowed in the Late Model/Super DIRTcar Series pit area in designated areas. Entry for personal vehicles will close at 4:45 p.m. each day.
6. Any camping vehicle, that is not a toter or attached to a race car trailer will require a "Lower Paddock" or "Upper Overflow" Camping permit.
7. The Racing Electronics Switch/Solo or a One-Way Comm (OWC) is mandatory Driver radio and AMB scoring transponder rental are available.
8. All prize money will be issued from Super DIRTcar Series to designated payee.
9. Participants in this event must be a 2019 DIRTcar member and have participated in a minimum of one Super DIRTcar Series event during the 2019 season.

- 10. Qualifying will be based on timed practice in Groups. The number of groups will be based on the final car count. Timed Qualifying laps will establish starting positions for qualifying races.
11. PROVISIONALS: Will be set per the 2019 Super DIRTcar Series rules, providing the Driver meets the entry deadline with an official post-marked entry blank by October 31, 2019.
